### INFORMATION DOCUMENT

pursuant to article 13 of Regulation (UE) 2016/679 of the European Parliament and Council dated 27 April 2016

Pursuant to article 13 of the General Data Protection Regulation - Regulation (UE) 2016/679 of the European Parliament and Council dated 27 April 2016 relating to the protection of natural persons with regard to the processing of personal data and the free movement of such data (hereafter "GDPR"), and our attention in furnishing you information related to the processing of personal data supplied by you for aims of the relationship with B.T.V. ### **Data Controller**

The Data Controller is B.T.V. S.p.A. with registered offices at Vicenza (VI), Via Luca della Robbia No. 25, tax code and registration number with the Companies' Register of Vicenza: 03277970244 (hereafter "Controller" or "Company") being part of the "Battistolli Group".

### Data Protection Officer (hereafter "DPO")



### Rights of the interested party



We inform you of the existence of a number of rights set out in the GDPR relating to personal data and related processing, which you may request of the data controller.

Right	Description	Manner of making it effective
Right of access to the data (article 15)	You may request: a) the purpose of the processing; b) the categories of personal data in question; c) the addressees or the categories of addressee to which the personal data has been, or will be, communicated, in particular if the addressees are of third party countries or international organisations; d) where possible, the forecast period of preservation of personal data or, if that is not possible, the criteria used to determine such a period; e) the existence of the interested party's right to require of the Data Controller the correction or cancellation of personal data or a limitation on the processing of personal data which concerns you or of which you oppose the processing; f) the right to place a complaint with a supervisory authority; g) whenever the data has not been gathered from the interested person, all the available information on its source; h) the existence of an automated decisional process, including the profiling referred to in article 22, paras 1 and 4, and, at least in such cases, significant information on the logic used, as well as the importance and the consequences foreseen on such processing for the interested party. Right to objection (article 21)	You have the right, at any moment, to object, as a whole or in part, to the processing of your data whenever the processing is carried out for the pursuance of a legitimate interest of the data controller, or when the processing is carried out for direct marketing aims. in such a case, the personal data will no longer be subject to processing for such purposes	Forms available on the data controller's website
Right to lodge a complaint with the Supervisory Authority (article 77)	You have the right to lodge a complaint with the Supervisory Authority whenever you consider that the processing concerning you violates the GDPR.	

The exercising of the above-mentioned rights is subordinate to the limits, the rules and procedures set out in the GDPR and which the interested party must know and implement. Furthermore, along with the provisions of article 12, para 3, the data controller will supply the interested party with the information relating to the action taken without unjustified delay and, in any case, not later than one month from receipt of the said request. If necessary that period may be extended to two months, depending on the complexity and number of requests. The Data Controller will inform the interested party of such a delay, along with the reasons for it, within one month of receipt of the request.

### **Amendments and updates**

This information document may be subject to amendments and/or integration, even as a consequence of the applicability of the GDPR, and of any future regulatory amendments and/or updates. The updated information document is available at any time on the data controller's website.
